Student Expulsion

Upon deliberation and with due consideration of all evidence, a student was found to be in violation of disorderly conduct, which is a violation of the Code of Acceptable Behavior and Discipline, specifically Item #240 and poses a threat to other students and school staff and could not be placed in a state funded agency program. As a result the Board of Education has expelled a student from Simon Kenton High School for one calendar year with services, or until credits for graduation are complete. If he/she wishes to be eligible for services he/she must complete the following:

- 1. Academic progress
- 2. Maintain satisfactory attendance
- 3. Positive behavior
- 4. Professional assessment and improvement plan
- 5. Show proof of the above growth by a state certifies professional assessor
- 6. Participation in an anger management program
- 7. Other stipulations as required by the Superintendent

This expulsion from Simon Kenton High School does not allow for the student to participate in or attend any Kenton County School District activities during the term of his/her expulsion.

You have the right to appeal this decision to the Kenton County Circuit Court.
